Position Description: Development of a Raspberry Pi to control the temperature of a cooling/heating unit able to communicate with a smartphone via blue tooth/wifi during DNA amplification

Qualifications: BSc and MSc in Biology, Biotechnology, Computer Science or other related degrees in lifesciences; research experience in applications and software development for biological data analysis. Good knowledge of English and Greek.

Contract Duration: 3 months, renewable based on the program's needs
