Job Description: Development of a high throughput drug screening platform for the evaluation of therapeutics against Alzheimer's disease

Qualifications: The successful applicant should hold a BSc in Biology/Biomedicine or related fields, and prior documented experience in molecular/cellular biology methods, modern microscopy techniques. Prior experience in nematodes genetics will be highly appreciated. The successful applicant should also have fluency in English.
