Required qualifications

- a) Hold a PhD degree, relevant to the subject of the Announcement
- b) Have the minimum qualifications specified in Article 18 of Law 4310/2014 as amended and in force:

For Principal Researcher (B' Grade) Position: a well-documented ability to organize and manage research and technological development programs, to coordinate and direct research and technological development in the individual projects of the research, to seek and attract funding from external sources. to fund the activities of the institute or center and to promote innovative ideas in science and technology. It is also required to have made original publications in internationally recognized scientific and technical journals or to have international patents and to have contributed to the advancement of science and technology and their applications and to have been recognized by other researchers for his contribution to science and technology.

- c) Be a Greek citizen or citizen of an EU Member State. For citizens of EU Member States adequate knowledge of the Greek language is required, as demonstrated by a Certificate of Attainment in Greek from a recognized Language Centre or by an equivalent certificate issued by the School of Modern Greek Language of the Aristotle University of Thessaloniki, granted at the request of the candidate.
- d) Should not have a criminal record
- e) For male candidates, to have fulfilled their military obligations or have been legally exempted from them by the time of their appointment

Documents to be submitted include:

- 2. Detailed CV prepared according to the EU guidelines (in Greek and English language
- 3. Detailed report of their research and a summary statement of research interests
- 4. A photocopy of both sides of the ID card or passport (for citizens of EU member states, a certificate from the respective authority of the state of the candidate's citizenship)
- 5. Copies of all degrees, domestic or foreign. Certified copies of all degrees should be submitted in case of appointment. For degrees awarded abroad, only for Greek candidates, is required to submit a certificate of approval from the Hellenic Academic Recognition Information Center (Hellenic NARIC) when submitting the application or alternatively upon appointment.
- 6. Statutory Declaration of Law 1599/1986 that the candidate has the typical qualifications

Submission of the application

Deadline for applications: Friday, 15 April 2022
