ANNOUNCMENT of ONE RESEARCHER POSITION (C GRADE)

The Institute of Molecular Biology and Biotechnology of the Foundation for Research and Technology-Hellas (IMBB-BR/FORTH), taking into account:

Announces One (1) Researcher Position

One (1) Researcher or C Grade (Assistant Researcher, equal to University Assistant Professor) in the field of "Molecular Biology and Biotechnology"

Candidates for this position should

- a) Hold a PhD degree, and have completed postgraduate studies relevant to the subject of the Announcement
- b) The minimum qualifications required for the recruitment or appointment of a researcher at the specific grade are defined in article 18 of Law 4310/2014 as amended and currently in force:
 - for grade C (Assistant Researcher), candidates are required to be scientists of high scientific experience and training, holders of a doctoral degree, working independently and autonomously to generate or improve knowledge and apply it for the production of products, devices, processes, methods and systems. have a documented ability to plan and execute research and technological development projects or parts of projects, to allocate parts or phases of the project to other researchers and to supervise or mentor them.

They are also required to have published original research papers in internationally recognized scientific journals.

- (c) Be free of any criminal conviction or sentence, or any prohibition or disqualification, or any judicial disqualification.
- (d) Male candidates must have fulfilled their military service obligations or have been legally discharged from such obligations.
- d) Should not have a criminal record

Documents to be submitted include:

- 1. An application form (Annex I), in which the candidate must request that his/her candidature be accepted and indicate the supporting documents to be submitted
- 2. A detailed curriculum vitae in accordance with the guidelines of the European Union (in Greek and/or English)
- 3. A detailed statement on their scientific and research work and a summary of their research interests
- 4. A copy of both sides of their identity card or passport (for citizens of Member States of the European Union, a certificate issued by the competent authority of the State of which the candidate is a national)
- 5. Copies of diplomas proving the required qualifications
 - Plain and legible copies if issued by a public body, or
 - Simple and legible copies of private documents, if they have been originally certified by a lawyer, as well as clear photocopies of the originals of those private documents that are certified by the services and institutions that fall under the regulation of Law 4250/2014, or
 - Clear photocopies of diplomas, provided that these documents have been certified by a lawyer in the first instance. In the case of qualifications from foreign universities, the university institution must be included in the National Registry of Foreign Recognized Higher Education Institutes (https://www.doatap.gr/national-registry-of-foreign-recognized-higher-education-institutes/). If the institution is not included in the above registry, a certificate of recognition from the DOATAP (Hellenic National Academic Recognition and Information Center https://www.doatap.gr/home_english/) or at least an application form is required at the time of application or, alternatively, at the time of recruitment
- 7. Statutory Declaration of Law 1599/1986 (only males) that at the time of their appointment they have fulfilled their military obligations or have been legally exempted from them
- 8. Statutory Declaration of Law 1599/1986 that the candidate has the typical qualifications
