### Position Description:

The postdoctoral researcher will contact immunology studies on transgenic mice aiming to identify novel mechanisms of iron regulation implicated in pathogenesis of respiratory fungal disease

### Qualifications:

PhD in Biology, prior documented experience on mouse immunology including work on models of lung inflammation is mandatory. Fluency in English and Greek is required.

**Contract Duration:** 12 months, renewable based on the program's needs
