### Info about the project:

**MicroBioPest** aims to establish an international research team in Crete, to develop Microbial Biopesticides. IMBB-FORTH, located at Heraklion Crete Greece, is one of the most prominent life science research institutions in Greece, with an outstanding record of scientific achievements, state of the art infrastructure and a broad range of research and innovation activities.

**Job Description:** The successful applicant will work mainly in the insectary and will be responsible for the rearing of insects and perform bioassays. The main insects that will be used are Diptera, Lepidoptera, Thysanoptera, Hemiptera and Coleoptera. He/she will also participate in writing progress reports and publications. The applicant should be accordingly adaptable and able to work with a range of people in a multicultural environment. Excellent knowledge of English is required.

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.
