The Postdoctoral researcher will contact immunology studies on mechanisms of autophagic deregulation in myeloid phagocytes from patients with infectious diseases

PhD in Biology, prior documented experience on mammalian cell cultures, macrophage biology, and confocal imaging will be considered favorably. Fluency in English and Greek is required.

Contract Duration: 12 months, renewable based on the program's needs
