Position Description:

The Program manager is expected to assist the coordinator of the programs in his daily financial and legal provisions. In doing so, s(he) is expected to:

- Represent the Coordinator in all communications with the Programme Officer (P.O.) and the Research Executive Agency;
- Advise and lead the Program beneficiaries on all developments needed for the projects' execution;
- Ensure the effective exchange of information between the Participants;
- Compile and issue the periodic and final scientific reports and submitting them to the EU;
- Assist with issuing the administrative/financial reports and submitting them to the EU;
- Assist in the organization of Annual meetings;
