The Researcher is expected to explore isothermal DNA amplification methods for pathogens detection as well as ways to extract genetic material from crude samples for direct nucleic acids amplification

- Demonstrate experience with molecular diagnostics
- Demonstrate work experience with handling human or other tissues
- Excellent oral and written skills in English and Greek language
