## **Position Description:**

The candidate is expected to develop isothermal nucleic acid amplification methods to quantify environmental DNA of invasive marine metazoans, while comparing to sequencing-based eDNA methods. The candidate is expected to develop a biosensor platform using acoustic wave and colorimetric detection systems that will function autonomously in the marine environment.

#### **Qualifications:**

- Holder of a BSc and MSc degree in Biology, or Marine Biology, or Biotechnology or Environmental Science or relevant degree
- Demonstrated experience with developing molecular assays; and/or molecular genotyping approaches; and/or bioinformatics; and/or biosensors
- Excellent oral and written skills in English and Greek language.

Contract Duration: 12 months with the possibility for further extension for 1 more year
