The research group of Neurogenetics and Ageing of IMBB under in the of the R&D project Excellence Hubs, CHAgeing - Connected Hubs in Ageing: Healthy Living to Protect Cerebrovascular Function (reference: GA: 101087071), financed by European Commission through the Horizon Europe Program, invites applications for two (2) PhD student positions.

Job Description: Investigation of genetic and dietary interventions with neuroprotective potential for healthy ageing

Qualifications: The successful applicant should hold a BSc and MSc in Biology/Biomedicine or related fields, and prior documented experience in Molecular Biology methods. The successful applicant should have been enrolled in a postgraduate program leading to a doctoral degree. The successful applicant should also have excellent scientific authoring skills and several scientific publications in peer reviewed journals in related fields and fluency in English.

Applicants for the post will be selected on the basis of the following criteria:

2.	MSc in Biological Sciences (Grade x 2 points)	20
3.	Laboratory experience in molecular/cellular biology techniques and imaging techniques (<3 months=5 points, 4-12months=10 points, >13 months=15 points)	15
6.	Scientific publications (1 publication = 5 points, >1 publications = 10 points)	10
7.	Oral and written skills in English (B1: 7 points, B2: 8 points, C1: 9 points, C2: 10 points)	10
8.	Interview* (by videoconference, for the shortlisted candidates> 50/70 points)	30

The shortlisted applicants will be invited for an interview. The evaluation criteria for the interview are:

- Perception - Judgement,
- Presentation skills,
- Communications skills

Contract Duration: 12 months, renewable based on the program's needs.

Total budget: The salary is at PhD student level, and adjusted in accordance with the provisions of the Greek legislation.

The application should consist of:

1. Application Form (see below)
2. Brief statement of purpose
3. Detailed curriculum vitae (CV)
4. Brief statement of purpose
5. The names and contact details of two referees
6. Scanned copies of academic titles
7. Scanned copies proving all the qualifications
8. Although the recipients must be enrolled in a cycle of studies leading to the attribution of an academic degree, at the time of application it is not necessary for the candidate to have made such an enrollment, and proof of enrollment must be presented until the fellowship is contractualized. Candidates are only required to meet the requirements to enroll in the training offer. If there are candidates already enrolled (including attending a course), they compete on an equal footing with those who are not enrolled.

Evaluation procedure

Applications will be evaluated by a three-member evaluation committee. In case of interview procedure, applicants will be invited to participate in person or teleconference.

In case of titles and qualifications awarded by foreign Higher Education Institutions, the provisions of the Law 55/2023 (article 36) and 4957/2022 (article 304) are implemented.

The results of the selection will be announced on the website of IMBB-FORTH. Applicants have the right to appeal the selection decision, by addressing their written objection to the IMBB secretariat within five days since the results announcement on the web. They also have the right to access (a) the files of the applicants as well as (b) the table of applicants' scores (ranking of applicants results).
